**NEW BUSINESS:** Sargent Corp Letter of Request - Mike Thibodeau and Scott Blanchard from Sargents attended the meeting to discuss the upcoming detour of Clewleyville Road from the intersection of Levensellar Road to allow for construction of the bridge over I395/Route 9 Connector Road. After discussion on how snow removal, bus routes, and EMS vehicles would be affected, the board approved the early detour request. Sargents will summarize the discussion items in a letter for approval at the next meeting.

E-One Fire Engine - **A motion was made, seconded and passed to approve financing with the Tax-Exempt Leasing Corp. to fund the purchase of the previously approved E-One Fire Engine and Approve Exhibit E (Lessee Resolution)** **D. McCluskey / D. Doughty** **Vote 5-0**

Monument Drive Sink Hole / Cross Culvert Replacement - Two bids were obtained. With winter weather ahead, paving plant closures, and no guarantee of culvert delivery, the Board decided to postpone the project for now, keep an eye on it over the winter, and replace it in the spring.

**ADJOURNMENT:** A motion was made, seconded and passed to adjourn at 6:37 p.m.


